Where can I get a tax credit for my electric vehicle?

Several government entities and local utilities offer electric vehicle and solar incentives for customers, often taking the form of a rebate or a tax credit. Rebates can be claimed at or after purchase, while tax credits are claimed when filing income taxes. Find state and local-specific incentives available in your area.

Which states offer EV rebates?

Georgia Power offers a \$150 rebate for EV home charging installation as well as reduced electricity rates based on time-of-use for EV owners. The State of Hawaii offers the Renewable Energy Credit incentive for a tax credit of up to 35% of system installation costs of solar panels.

Where can I get a tax exemption for an electric vehicle?

State emissions testing exemption. Rhode Island offers a post-sale rebate up of \$1,500 for the purchase or lease of an electric vehicle. An additional \$1,500 is available to customers who meet certain income requirements. Town of Warren provides excise tax exemptions up to \$100 upon registration of an EV.

How do I get a tax credit for EV charging?

Review the IRS website for complete requirements and consult a tax professional to determine your eligibility. 30% federal tax credit available for EV charging equipment installed at eligible locations by June 30, 2026. Federal tax incentive information for Powerwall, solar panels and Solar Roof may continue to change.
